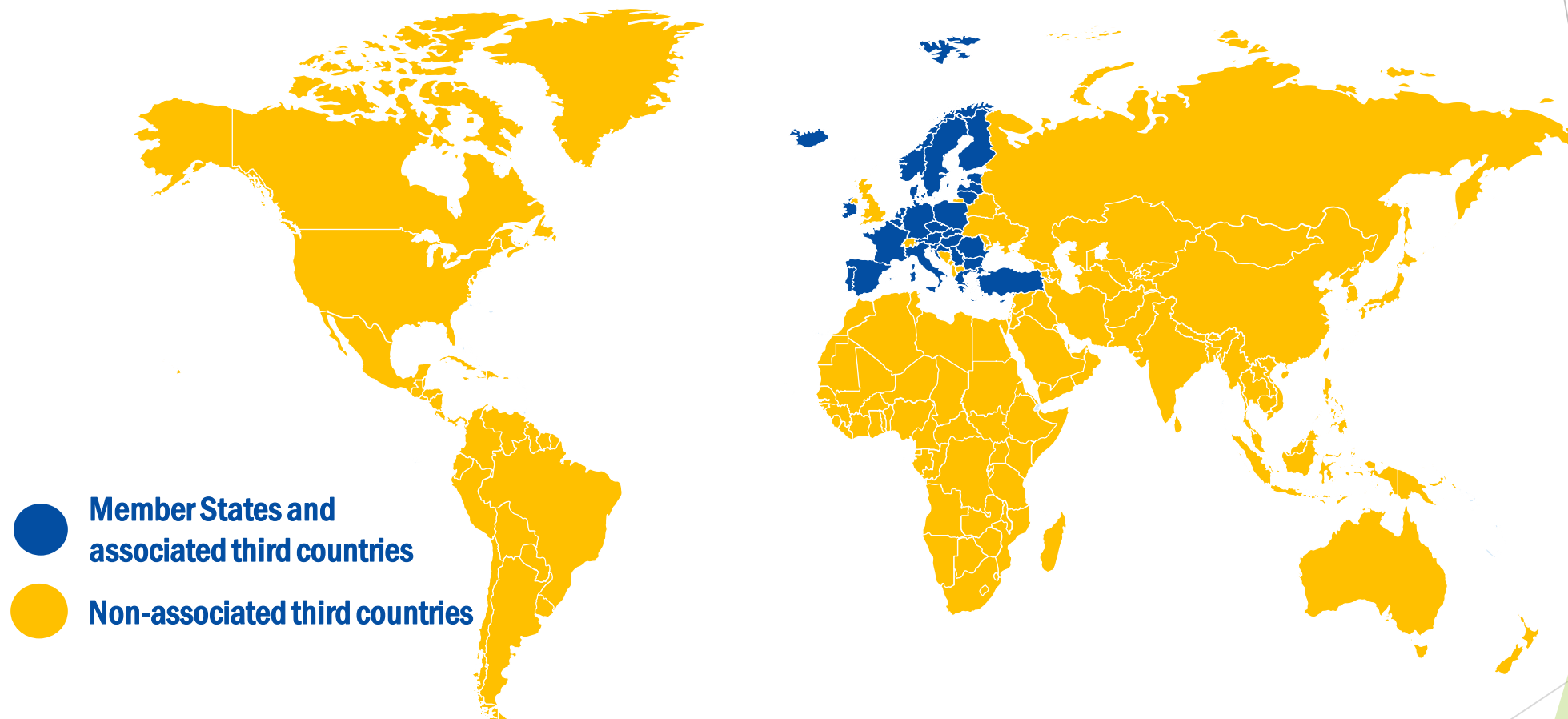

Strand 1 - Fostering access to cooperation in Higher Education

Target groups

- HEIs from **least developed countries**
- HEIs located in **remote regions/areas**
- **Newcomers or less experienced**
- Individuals with **fewer opportunities.**

Enhancing the management/administrative capacity

Reforming and modernising university governance

reforming and modernising the university governance, including the enhancement of services in particular for the benefit of students (student guidance, counselling and job orientation etc.);

International Relation Offices

establishing or strengthening international relations offices and elaborating internationalisation strategies;

Quality Assurance

establishing new or developing existing quality assurance units and processes/strategy within HEIs;

Capacity

creating or increasing the capacity of planning and evaluation units;

Mobility

building capacities to support students and staff mobility activities.

Ensure high quality and relevant education

- modules or **study programmes**, technical or professional orientations of programmes
- establishing **intensive study programmes** bringing together students and teaching staff from participating HEIs for shorter study periods
- developing capacities **for postgraduate student and academic staff** as well as promoting postgraduate students and/or staff mobility
- implementing **training courses for HEI staff**



Increasing the accessibility of individuals with fewer opportunities

- ▶ developing **remote and inclusive learning pathways** and opportunities by relying on digital technology and e-learning for vulnerable students
- ▶ updating the **digital technology to develop specific services** aiming at ensuring equal and fair learning opportunities to students with disabilities
- ▶ promoting initiatives aiming at **positive discrimination by empowering women and ethnic/religious minorities**

- **Internationalisation**
Bologna type reforms, surveys and studies etc

Types of CBHE projects by geographical scope

National

- Relevance of the proposal: proposals need to be relevant for the country and to the need of all HEIs involved
- Balanced involvement and clear benefits for all participating third country HEIs not associated to E+

Multi-country

- Relevance of the proposal: needs to be common to all third countries; clear justification for involvement of more than one Region in a cross-regional project
- Balanced involvement and clear benefits for all participating third country HEIs not associated to E+ and third country HEIs not associated to E+ HEIs



CBHE - Consortium minimum requirements

National projects addressing only one third country not associated to the Erasmus+ programme):

Country participation

One eligible third country not associated to the programme and a minimum two EU Member states or countries associated to the programme must be involved in the project.

HEI participation

Projects must include, as full partners, the minimum number of HEIs, as follows:

- ▶ Minimum 1 HEI from each participating EU Member state or third country associated to the programme, and
- ▶ Minimum 2 HEIs from the participating third country not associated to the programme

In addition (Strand 3 only):

- ▶ Projects must also involve, as a full partner, the national competent authority (e.g. Ministry) responsible for higher education of the eligible third country not associated to the programme targeted by the project.



CBHE - Consortium minimum requirements

Multi-country projects addressing two or more third countries not associated to the Erasmus + programme

Country participation

Minimum two eligible third countries not associated to the Programme and minimum two EU Member states or countries associated to the Programme must be involved in the project. Third countries not associated to the programme can be from the same Region (regional projects) or from different Regions (cross-regional projects) covered by the Action.

HEI participation

These projects must include, as full partners, the minimum number of HEIs, as follows:

- ▶ Minimum 1 HEI from each participating EU Member state or third country associated to the Erasmus + programme, and
- ▶ Minimum 2 HEIs from each of the participating third countries not associated to the Erasmus + programme.

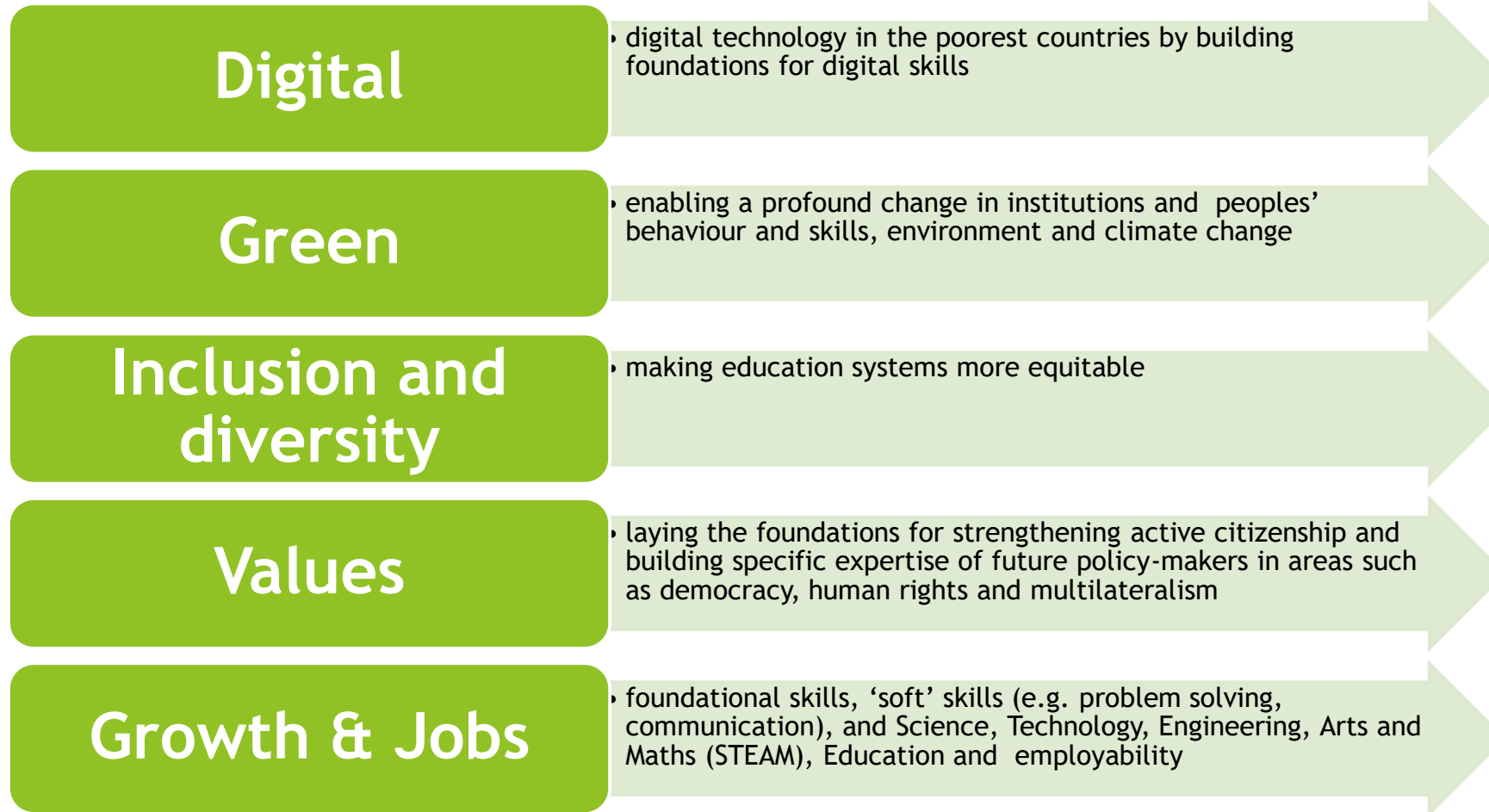
In addition (Strand 3 only):

- ▶ Projects must also involve, as a full partner, the national competent authority (e.g. Ministry) responsible for higher education of the eligible third country not associated to the programme targeted by the project.

The number of organisations from EU Member States and third countries associated to the Programme **may not be higher** than the number of organisations from third countries not associated to the Programme.

Lump sum II: approach - basic principles

In the proposal, applicants must provide a detailed estimation of costs and a split of the lump sum per work package and per beneficiary

Evaluators assess cost details during evaluation and make recommendations if needed.

Based on this, the lump sum is fixed during grant preparation

Lump sum II- work packages

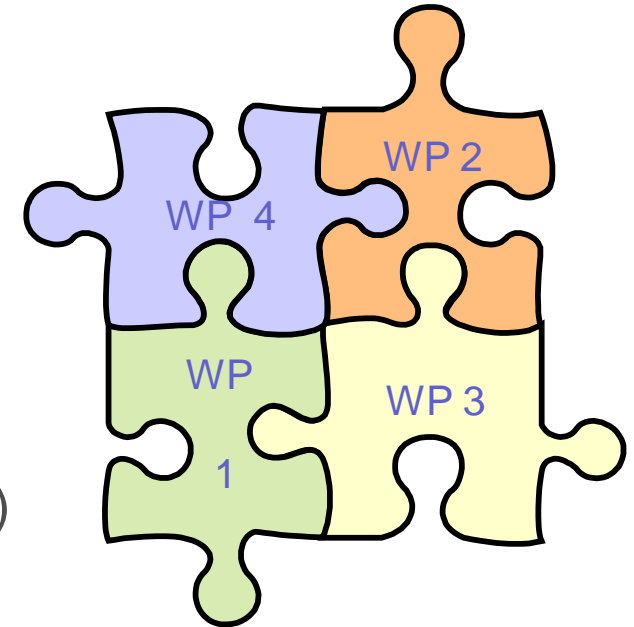
As many as needed but no more than what is manageable

'Work package means a major sub-division of the proposed project.'

Therefore:

- ✘ A single activity is not a WP
- ✘ A single task is not a WP
- ✘ A % of progress of work is not a WP (e.g. 50 % of the tests)
- ✘ A lapse of time is generally not a WP (e.g. activities of year 1)

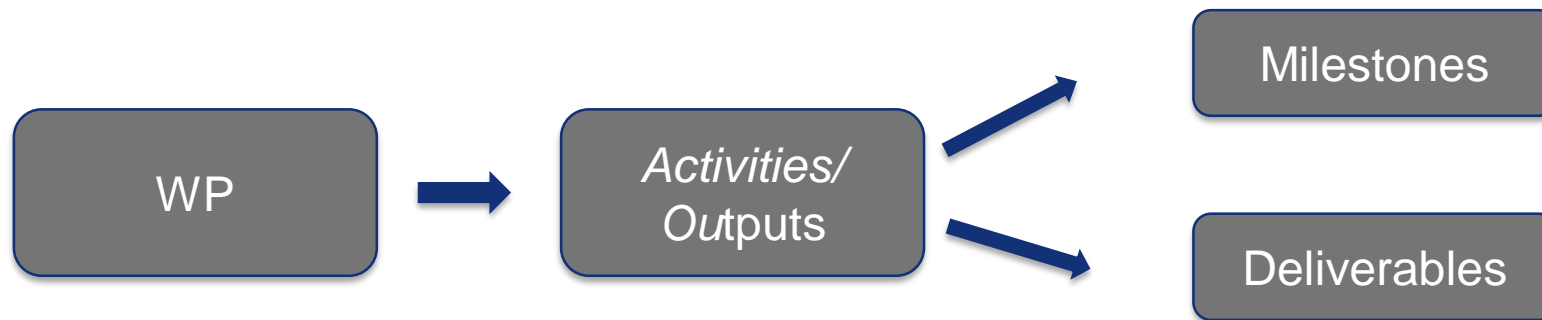
Horizontal work packages (e.g.: Management, Dissemination and Exploitation, etc.) may be approached differently

Lump sum II - work packages

- Applicants will divide their projects in WPs and reflect this division in the budget attached to the applications
- Each work package will define the activities/outputs and the corresponding deliverables.

Sustainability, impact and dissemination of the expected results

International Credit Mobility (ICM)

What is ICM?

- ▶ **Short-term mobility of students and staff between Programme and Partner counters**
- ▶ **Supports individuals and institutions:**
 - Benefits for students: **Key skills and competencies, professional development, enhanced employability, teaching methods, etc.**
 - Benefits for HEIs: **Increased capacities, attractiveness & internationalization; improved quality of higher education**

How does it work?

- ▶ Decentralized action: Managed by National Erasmus+ Agencies
- ▶ Global action: the world is divided into **regions**, which have different budgets allocated
- ▶ Total ICM budget for 2021-2027 over **1 billion EUR**
- ▶ Budget for the **Western Balkans increased to 19%** (from 18% in the previous period)

Two strands of the international dimension:

- ▶ International outgoing mobility supported by internal policy funds (KA131)
- ▶ ICM - international outgoing and incoming mobility supported by external policy funds (KA171)
- ▶ KA131: up to 20% of project grant for international mobility, one budget for the whole world
- ▶ KA171: earmarked budget envelopes per region

ICM activities supported:

- ▶ Short-term mobility for higher education students and staff (academic and administrative)
- ▶ All levels: Bachelor, Master and PhD candidates
- ▶ Mobility in any subject or academic discipline
- ▶ Also supports traineeships for students and training for staff
- ▶ Study periods and traineeships of 2 - 12 months
- ▶ Blended mobility (physical mobility of 5 - 30 days + virtual component)
- ▶ Opening up to recent graduates for traineeships

Implementation

- ▶ ICM funds can be shifted between countries in the same region => more flexibility in budget management
- ▶ HEIs apply only for student/staff mobility without specifying types of activity (studies/ traineeships or teaching/training)
- ▶ Partners in an ICM project can send and host students and staff as described in their submitted project
- ▶ Restrictions for certain countries: Bachelor/Master student mobility is only possible from third countries to Europe - this means third-country universities can send but not host
- ▶ Region 1 - Western Balkans is exempted from the restriction:
- ▶ European partners may use a part of their intra-European mobility budget (KA131) to fund their student's mobility to restricted countries under ICM (KA171).



ICM funding

- ▶ Organizational support:
500 EUR/participant
- ▶ Individual support:
Students: 700-900 EUR/month
Staff: 140-180 EUR/day
In the case of blended mobility: 70 EUR/day up to the 14th day of activity and 50 EUR/day from the 15th day to the 30th day of activity
- ▶ Travel costs: 20-1500 EUR, depending on the distance traveled
- ▶ Top-ups: for participants with fewer opportunities for green travel

Who can apply and how:

- ▶ Applicant must be Higher Education Institution (HEI) from EU member states and/or third countries associated to the Program
- ▶ **HEIs from BiH can be partners, but not applicants**
- ▶ The ICM project in their application lists the countries and partner universities they intend to cooperate with, as well as their cooperation plan in each region
- ▶ Upon successfully passing the established quality criteria, they will be allocated an ICM grant spread in different regional envelopes
- ▶ Inter-Institutional Agreement is needed between the main applicant in Europe and every partner university in third countries before mobility can start
- ▶ Learning agreement with or Mobility agreement with staff and Grant agreement with participants needs to be signed by all parties involved

Erasmus Mundus Joint Masters (EMJM)

- ▶ **Highly integrated transnational study program at MA level**
- ▶ **A Master program of excellence open to all disciplines**
- ▶ **Delivered by an international consortium of HEIs from different countries worldwide and other educational and/or non-educational partners**
- ▶ **Offering high-level scholarships to excellent students worldwide**

EMJM - main objectives

- ▶ Support **quality, innovation, excellence, and internationalization** of HEIs through **academic cooperation** within the EHEA and beyond
- ▶ Increase the **quality and attractiveness** of the EHEA
- ▶ Increase **synergies** between HE, innovation, and research
- ▶ Improve **competencies, skills, and employability** of Master graduates
- ▶ Respond to **societal and labor market needs**

Erasmus+ countries:

- ▶ EU Member States + Third countries associated to the Programme: Norway, Iceland, Liechtenstein, North Macedonia, Serbia, *Türkiye*
- ▶ Third countries not associated to the Programme: All other countries throughout the world (**including BIH**)

EMJM - main requirements (1)

- ▶ a **jointly designed fully integrated curriculum and common implementation procedures** based on the Standards for Quality Assurance of Joint Programmes in the EHEA (e.g. joint selection, promotion, common services, joint administrative and financial management, etc.)
- ▶ Delivered by a consortium of **at least 3 HEIs from 3 different countries** of which at least 2 must be EU Member States and third countries associated to the Programme
- ▶ **International outreach** to attract and enroll excellent **students worldwide** (part of which may benefit from an EMJM scholarship)

EMJM - main requirements (2)

- ▶ **compulsory physical mobility** for all enrolled students - at least 2 study periods in two countries with a minimum duration of one academic semester each (different from the country of residence of students)
- ▶ **contribution of scholars/guest lecturers** to teaching, training, and research activities
- ▶ delivery of a **joint degree or multiple degrees** (joint degrees are highly recommended where national legislation allows it)
- ▶ **At the application stage EMJM proposals must present fully developed joint study programs, ready to be run and advertised worldwide after their selection**



EMJM Set-up

- ▶ Fixed Grant Agreement of **74 months** independently from the length of the master
- ▶ **At least 4 master editions** lasting **1 to 2 academic years** (60, 90, or 120 ECTS)
- ▶ **The 1st edition** starts no later than the academic year following the year of the project selection
- ▶ **At least 2 study periods in 2 countries** (of which at least one in an EU Member State or a third country associated to the Programme and both different from the country of residence of students)
- ▶ **Geographical balance of students:** no more than 10% of total scholarships per project awarded to students of the same nationality (does not apply to additional scholarships for targeted regions)

EMJM taking part as an organisation

- ▶ Applicants can be **any eligible HEIs** from EU Member State or a third country associated to the Programme or a third country not-associated to the Programme (**including BiH**)
- ▶ Minimum consortium: **3 HEIs from 3 different countries**, of which at least 2 must be an EU Member State or third country associated to the Programme
- ▶ HEIs in EU Member States and third countries associated to the Programme: must hold **valid ECHE**
- ▶ HEIs in third countries not associated to the Programme: **should commit to ECHE principles** in the Partnership Agreement
- ▶ HEIs from EU Member States, third countries associated to the Programme and third countries not associated to the Programme: must **have completed accreditation/evaluation of the master programme**



Taking part as an individual

- ▶ Open to students worldwide
- ▶ Applicants:
 - ✓ must hold a **first higher education degree** or equivalent
 - ✓ must **not have benefited previously from an EMJM** scholarship
- ▶ The best ones can benefit from a scholarship depending on the number of scholarships available
- ▶ Students apply directly to the EMJM consortium Catalogue with ongoing EMJMs offering scholarships: <https://ec.europa.eu/erasmus-mundus>

Benefits for students

- ▶ High degree of **expertise** with a specialization component
- ▶ A unique **mobility experience** recognized by joint/multiple degrees
- ▶ Attractive **EU scholarship** for the best-selected students
- ▶ High **employability** through key competencies and soft skills

EMJM grant composition:

- ▶ **Scholarship:** up to 1400 EUR/month (max. amount per student: 33,600 EUR for 24 months), maximum 60 scholarships per project)
- ▶ **Institutional cost:** 750 EUR/enrolled student/month
- ▶ **Individual/special needs:** 10 different unit costs varying between 3,000-60,000 EUR (if below € 3000 it should be covered by institutional costs)

Erasmus Mundus Design Measures (EMDM)

- ▶ Short-duration **grant to support institutions** in the set-up of a new joint master program in Europe (and beyond)
- ▶ **One beneficiary** mobilizing a group of other HEIs
- ▶ **Independent funding scheme** from EMJM (independent calls for proposals)

Expected outcomes of an EMDM (1)

- ▶ Offers a **fully integrated curriculum delivered by a consortium** (involving at least 3 HEIs from 3 different countries, of which at least 2 must be EU Member States or third countries associated to the Programme)
- ▶ Aims at **attracting excellent students** worldwide
- ▶ Includes **physical mobility** for all recruited students
- ▶ Leads to either a **Joint degree** or **multiple degrees**

Expected outcomes of an EMDM (2)

- ▶ **Joint program design** and joint procedures
- ▶ **Joint administrative and financial management**
- ▶ **Common services** offered to students
- ▶ **Joint promotion and dissemination**
- ▶ A draft **joint Partnership and Student Agreement**
- ▶ A **joint degree policy** and launch of the **accreditation process**
- ▶ + **explore opportunities offered by the European Approach for Quality Assurance of Joint Programs** (if national legislation allows)

EMDM Set-up

- ▶ **One beneficiary** mobilizing a group of other HEIs (mono-beneficiary grant)
- ▶ **Fixed duration of 15 months**
- ▶ **EU Grant: fixed lump sum contribution of 55.000 EUR** (for costs linked to the activities necessary to set up the new joint master program)
- ▶ Applications can be submitted by **any HEI** in an EU Member State, a third country associated to the Programme or a third country not associated to the Programme (**including BiH**)
- ▶ For HEIs in EU Member States and third countries associated to the Programme: **valid ECHE**

Enhancing awareness of the European Union:

- **European citizenship and values**
- **Role of the EU** in a globalized world
- Facilitating future **engagement** as well as **people-to-people dialogue**.
- Vector of **public diplomacy** in third countries, promoting EU values and enhancing the visibility of the European Union
- Scope of EU studies may vary so long as an **EU angle** is explored

JEAN MONNET ACTIONS FOR HIGHER EDUCATION: AIMS

- To promote excellence in teaching and research in EU studies worldwide
- To foster dialogue between academic world and society ➔ policymakers, civil servants, civil society, representatives of different levels of education, the media
- To generate knowledge and insights in support of EU policy-making & strengthen the role of the EU within Europe and the world
- To reach out to a wider public (beyond academia and specialized audiences) ➔ bringing EU knowledge closer to society
- To function as vector for public diplomacy towards partner/third countries ➔ promoting EU values and enhancing the visibility of what the EU stands for and what it wants to achieve.

Jean Monnet:

Some Tips

- ✓ **Be coherent**: avoid contradictions and “cut and paste” style applications
- ✓ **Be concrete**: use examples, justify your claims, provide evidence
- ✓ **Be clear**: read the questions carefully, provide information in the correct order as indicated in the form
- ✓ **Be explicit**: take nothing for granted; don't assume that experts have prior knowledge; avoid abbreviations or explain them
- ✓ **Be realistic**: the application is the basis of your project to be; it is also the cornerstone of the commitment you will sign
- ✓ **Remain focused**: concentrate exclusively on what is asked of you
- ✓ **Eligibility**: make sure you have followed all instructions and that the proposal meets all mandatory requirements
- ✓ **Keep it simple**: use short sentences, vary the length if you wish to make it more interesting but keep it simple and focused

What are ‘virtual exchanges’?

- ▶ Online people-to-people activities that promote intercultural dialogue and soft skills development.
- ▶ They make it possible for every young person to **access high-quality international and cross-cultural education** (both formal and non-formal) without physical mobility
- ▶ They take place in **small groups** and are always **moderated by a trained facilitator**
- ▶ They should be **easily integrated into youth (non-formal education) projects or higher education courses**



Specific objectives:

- ▶ Encouraging **intercultural dialogue** with Partner Countries and increasing tolerance through online people-to-people interactions
- ▶ Promoting various types of virtual exchanges, allowing more young people to **benefit from intercultural and international experience**
- ▶ Enhancing **critical thinking and media literacy**, particularly in the use of the internet and social media
- ▶ Fostering the **digital and soft skills development** of students, young people, and youth workers
- ▶ Promoting **citizenship and the common values** of freedom, tolerance and nondiscrimination through education
- ▶ Strengthening the **youth dimension** in the relations of the EU with Partner Countries

Expected outcomes:

- ▶ Wide variety of activities and topics is possible, but all projects are expected to have a **learning dimension** and to report on it
 - ▶ On-line facilitated discussions (as part of youth projects)
 - ▶ On-line facilitates discussions (as part of higher education courses)
 - ▶ Training of youth workers for virtual exchanges
 - ▶ Training for university professors/staff for virtual exchanges
 - ▶ **Interactive** open online courses (strong focus on cross-border exchanges)
- ▶ Rely as much as possible on existing tools and platforms!
- ▶ Participants must be based on the countries of the organizations!

- ▶ Max. EU Grant: **500,000 EUR/project**
- ▶ Max. EU co-funding 95%
- ▶ Total budget available in the last call was **4 million EUR**
- ▶ **Duration: 3 years**

Eligibility Criteria: What must partnerships look like?

- ▶ A minimum of 2 higher education institutions and/or youth organizations from 2 or more different EU and/or third countries associated to the program
 - ▶ AND
 - ▶ A minimum of 2 higher education institutions and/or youth organizations from 2 or more eligible third countries not associated to the program within the same region
- ▶ The number of organizations from the EU and third countries associated to the Program may not be higher than the number of organizations from third countries not associated to the Program*

Award Criteria: Tips for applicants

- ▶ Be **concrete** in the description of your objectives and activities
- ▶ Pay attention to the **integration of activities** and consistency with the objectives
- ▶ Pay equal attention to **all award criteria**. Scoring below the threshold in one award criteria makes the project automatically ineligible
- ▶ **Impact** often described in terms of participation in events rather than in terms of changes in knowledge, behavior or skill

What are European Universities?

- ▶ **highly ambitious transnational alliances of higher education institutions**
- ▶ based on a co-envisioned **long-term institutional and strategic cooperation** focused on sustainability, excellence, and European values
- ▶ include partners from **all types of higher education institutions** and cover a broad geographic scope across Europe
- ▶ offer **student-centered curricula jointly delivered** across inter-university campuses, where diverse student bodies can build their own programs and experience mobility at all levels of study
- ▶ adopt a **challenge-based approach** according to which students, academics and external partners can cooperate in inter-disciplinary teams to tackle the biggest issues facing Europe today

What is European Universities initiative?

- ▶ In October 2018 the European Commission launched **1st Erasmus+ call** to higher education institutions to start testing different models for European Universities
- ▶ After three calls thus far **44 European Universities** have already been **created** involving 340 HEIs from 31 countries
- ▶ Building on the progress during the initial phase, the initiative is now an integral part of the Erasmus+ 2021-2027 programme
- ▶ European Universities are a **flagship initiative** of the “European strategy for universities“ that sets the ambition to support **60 European Universities** involving more than 500 higher education institutions by mid-2024
- ▶ **European Universities call is now open to universities from Western Balkan countries, including BiH**

 - ▶ The applicants must be Higher Education Institution (HEI) holding a **valid Erasmus Charter for Higher Education (ECHE)**, including:
 - ▶ Higher Education Institutions already involved in deep institutional transnational cooperation,
 - ▶ Higher Education Institutions wishing to establish new deep institutional transnational cooperation in a new alliance;
 - ▶ any other organization consisting of the above referred higher education institutions - specifically set up with the purpose of implementing deep institutional transnational cooperation, including joint educational activities

Who can apply and how:

- ▶ **The associated partners can be:**
 - ▶ Any higher education institution established in an EU Member State or a third country associated to the programme holding a valid ECHE Erasmus Charter for Higher Education.
 - ▶ Any public/private organization from an EU Member State or third country associated to the programme active in the field of education and training, research and innovation or in the world of work.
 - ▶ Any higher education institution established in a third country not associated to the programme that is part of the European Higher Education Area (Bologna Process) or in Kosovo.

Consortium composition

- ▶ Consortium must consist at least 3 applicants (beneficiaries not affiliated entities), which complies with the following conditions:
 - ▶ Minimum 3 eligible higher education institutions from 3 different eligible countries.
 - ▶ A higher education institution may participate as a full partner in only one European Universities alliance funded by the Erasmus+ programme at the same time.
 - ▶ A higher education institution may only participate as a full partner in one single European Universities application; they may participate in other applications only as associated partners.

Duration

- ▶ Projects should normally last **48 months** (extensions are possible, if duly justified and through an amendment).
